Equipment: Germs on masks	12	E	Disinfect masks after each use.	4	•Avoid swapping masks during the rotation. •Spray masks with disinfectant after each use.	Yes
People: Incorrect Use	8	M	CYC Staff to train supervisors on use, prior to beginning of activity. Only play in the designated area.	4	•All Activity Supervisors to be trained by a CYC Instructor. •Wrist guards are provided on request, keep the forward arm slightly bent – elbow pointing out to the side to prevent injury. •Archery – Arrow Tag is done only on the paintball course at the south end of camp near the BMX track or the set field location, unless prior approval given. Equipment: Damage to Equipment	8	M	Do not dry fire the bows. Do not undergo manoeuvres on the course that could damage gear. CYC Staff to check prior to putting out gear.	2	•Do not dry fire the bows (an unloaded bow). •Never leave the archery equipment out or unattended. •Do not undergo manoeuvres on the course that could damage gear, e.g. roles or dives with bows and arrows. •Avoid walking on arrows. •Allow time before the end of the session to find all the arrows, count them before and after the session. Environment: Natural Hazard	6	M	Make use of shelter. Wear hats/sunscreen. Activity not to be operated in severe weather events, excessive rain/wind, or natural disaster. CYC Staff to be aware of changing conditions, esp. high winds, and pause/stop the activity when necessary.	2	•Wear sunblock on fine days.	Yes
Emergency procedures Stop activity, assess situation, administer first aid, call emergency services, if necessary, notify camp organisers and camp staff, and fill out an incident form when practicable.
