					<p>Appropriate clothing that will not tangle in bike, we recommend long pants and long tops</p> <p>Riders to completely ride and perform braking on flat and show proficiency to the CYC Instructor before being allowed to enter track</p> <p>Riders to be warned not to attempt tricks/jumps that may exceed their ability and start on the lower half of track</p>	
Equipment: Damage to equipment	4	M	CYC Staff to check prior to putting out gear, after a crash and during monthly checks	1	Instructor to visually check all bikes for signs of damage; if damage has occurred, the bike must be pulled from use until checked by an instructor.	Yes
<p>Emergency procedures</p> <p>Stop activity, assess situation, administer first aid, call emergency services if necessary, notify camp organisers and camp staff, including filling in an Incident Report Form</p>
