Condition: being hurt while crossing the road	10	M	Be careful, Supervisors to actively supervise participants	5	Be careful when crossing the road, make sure all participants wait for instructions from their supervisor before crossing the road	Yes
People: Incorrect use or misuse of equipment	8	M	Warn of sharp hooks Supervisor to use sharp knife only Do not eat bait	6	Be careful of sharp hooks Do not leave lines lying on the ground Supervisor to use sharp knife only Do not eat bait	Yes
Condition: Sharp Objects	8	M	To prevent hooks, knives, sticks, or other sharp objects from injuring people's feet, all participants and supervisors must wear covered shoes Crocs do not count due to slipping and sharp object hazards.	2	All participants and supervisors must wear covered shoes, crocs do not count.	Yes
Environment: Natural Hazard	8	M	Wear hats/sunscreen CYC Staff to be aware of changing conditions and not use in severe weather events	2	Wear a hat and sunscreen	Yes
