Equipment: Damage to equipment	15	M	CYC Staff to check prior to putting out gear and on monthly checklists Take proper care of all gear	5	At the end of the session please make sure the paddle boats are returned to the deck Hang life jackets up to aid in drying Keep paddle boats away from other boats and obstacles	Yes

Environment: Slippery Surface	12	M	Do not run on Camp Waipa Wharf as water can cause a slip hazard. Regularly waterblast wharf; in monthly checks	3	Do not run on the main lake wharf	Yes
People: Misuse of equipment	10	E	Supervised activity	5	1 Activity Supervisor over 16 years old and able to swim, to 16 participants (with kayaks operating) or 2:16 (without kayaks operating) Maximum 4 to a boat	Yes
Environment: Natural Hazard	10	M	Wear hats/sunscreen CYC Staff to be aware of changing conditions	2	Wear appropriate clothing and protection for weather Wear a hat and sunscreen	Yes

People: Impairment of Supervisor	6	E	CYC Staff to look out for signs of impairment	3	-	Yes
People: Urine	6	E	Prevent Urinating in Lake	3	Make sure participants have been to the toilet before activity	Yes

### Emergency procedures

Stop activity, assess situation, administer first aid, call emergency services if necessary, notify camp organisers and camp staff, and fill out an incident form when practicable.

### Competencies for Activity Sign Off

- Be able to manage a group of participants 1:16 (if using with kayaks) or 2:16 (if used separately, 1 supervisor must be on the water)

- Looking out for unsafe actions
- Know where to get help/locate CYC Staff or group organizers
- Technical information
