Wear fitted life jackets and communicate experience level with all supervisors. | Yes | | |
| People: Flying fox boundary | 15 | М | Prevent Swimming under the flying fox | 5 | The rope separating the flying fox is the upstream boundary for Swimmers No Kayaks, Paddle Boats, or swimmers past rope boundary | Yes | | |
| Environment: Slippery Surfaces | 12 | М | All slippery surfaces will be monitored by staff, including regularly water blasting wharf around the main Lake when it becomes slippery. Participants must be informed of slipping risk and take extra precautions, incl. not running around waterfront areas, or play fighting on wharf or pontoon. Have supervisors help lift children from the water, if they are getting out on the wharf. | 4 | No running during this activity, or along the waterfront/wharf due to slipping hazard Supervisors must assist children when getting out of the lake/pond around hard areas to exit No play fighting or dangerously pushing other participants off pontoon or wharf. | Yes | | |
| People: Poor supervision | 12 | М | Signed off and checked during use | 4 | One adult on the water and one adult helping the campers in and out of the water, checking life jackets, over 16 years old and be able to swim, per 12 participants. | Yes | | |
| Environment: Natural Hazard | 10 | М | Wear hats/sunscreen CYC Staff to be aware of changing conditions and not use in severe weather events. | 2 | Wear hats/sunscreen and appropriate clothing/togs for weather | Yes | | |
